# **Privacy Policy**

#### 1. Introduction

The privacy policy for the Poster Maker explains how user data is collected, used, and protected by the app. This policy is important to ensure user privacy is respected and their personal information is kept secure. We take your privacy seriously and want to ensure that you understand how we collect, use, and share your information when you use our Poster Maker: Flyer Designer (the "App"). # Explanation of the purpose of the privacy policy

We collect information related to your use of the app, including tracking data, crash reports, device details, and your app usage patterns. This helps us improve app functionality and user experience.

## 2.5 Analytics Data

Poster Maker may collect data for analytical purposes, including app tracking, usage data, universally unique identifiers (UUID), crash data, device information, geographic location, language preferences, and the resources you use in the app.

## Information Regarding the Utilization of Collected Face Data

We are using the "Vision" framework to collect face points in our system. We employ a tool called "VNDetectFaceRectanglesRequest" to figure out if there's a face in a chosen image. If the face points count is greater than 1, we identify a face in the selected image. If not, a message pops up, and the face recognition controller goes back. We only keep these face points in a local storage. And when you close the face recognition tool, all the stored data goes cleared automatically. It is crucial to emphasize that facial data points are stored locally and are never shared with any third parties. Moreover, the removal of the controller instance results in an automatic clearing of all stored data, ensuring a secure and privacy-conscious approach to the management of collected face data. Your facial data points are stored exclusively locally if used for the cartoon and background removal feature and are cleared either after use or when the controller is dismissed.

### 3. How We Use Collected Information

The information we collect is used to:

- Provide, operate, and maintain our app and its services.
- Improve and customize user experience.
- Communicate with you regarding support, updates, or relevant features.
- Analyze usage patterns to enhance app performance and features.
- Who Has Access to Your Information?

We provide access to your information only to those who need it to provide our services, including our employees and trusted third-party service providers. Our employees are bound by

strict confidentiality obligations, and we only share information with third parties that help us operate and enhance our app.

#### 9. Deletion Policy
